MAIJOGMAI RURAL MUNICIPALITY **has allocated funds** towards the cost of **Construction of 15 Bed Primary Hospital Building at Maijogmai Rural Municipality** and intends to apply part of the funds to cover eligible payments under the Contract ID No. **MJRM/NCB/WORKS/078/079-09** Bidding is open to all eligible bidders as per Section V of bidding document.
2. **MAIJOGMAI RURAL MUNICIPALITY** invites electronic bids only from eligible bidders for the construction of works mentioned above under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Nrs. 14,50,00,000.00**
 - Minimum Work experience of similar size and nature: **1 number of Government hospital building project with lift with minimum value of Nrs. 15,50,00,000.00**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building Project with 270 MT Reinforcement works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building Project with 2300 cum. of Concrete Works**
 - At Least Prime Contractor, Management Contractor or Sub Contractor should have experience of constructing a **Building Project with 750 cum. of Brick Works**

Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to minimum of **NRS 60,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid and in the following Bank.
